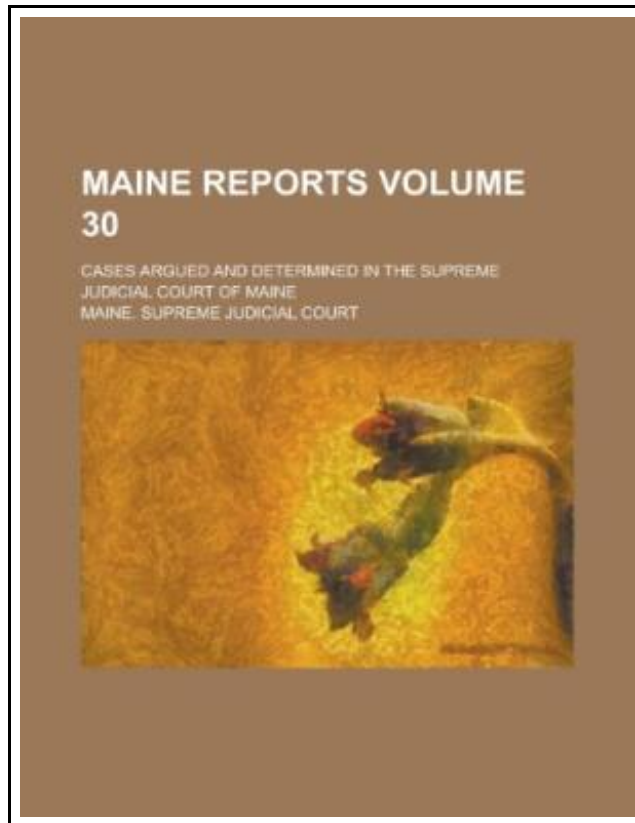

Ames, that where indorsement is made at the time of making the note, the person indorsing is to be treated as an original promisor, because as he cannot be answerable as an indorser, he shall be answerable as an original promisor. All this is obiter dicta. The Court has not decided, that in case of a negotiable note, where the defendant might be held as indorser, that he would be answerable as promisor. The Court say in this case, that they would not be justified in extending the liability of these anomalous indorsers. The New York cases, that are cited in the above, either did not sustain the positions for which they were cited, or have been since overruled. 3. Baker v. Briggs, 8 Pick. 122, recognizes the doctrine that a defendant, in a case like this, would be chargeable, as an original promisor. 4. Chafiee v. Jones, 19 Pick. 260, recognizes the same. C.
